### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, Pool operations complied with applicable requirements and provided adequate safeguarding of public resources. The Pool also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Washington State Transit Insurance Pool from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Pool's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General revenues
- Payroll
- Open public meeting minutes

- Key accounting systems
- Solvency
- Association agreement

### INFORMATION ABOUT THE POOL

The Washington State Transit Insurance Pool was formed by an inter-local agreement in 1989 to provide self-insurance and risk management for its transit members. The Insurance Pool coordinates the purchase of joint insurance and the hiring of personnel to provide risk management, claims-handling and administrative services. The Insurance Pool is committed to reducing members' cost of risk through the delivery of comprehensive and innovative risk management services. There is a 25-member Board of Directors composed of representatives from each member transit agency that meets on a quarterly basis.

An elected, eight-member Executive Committee governs the Pool. The Executive Committee appoints management to oversee the Insurance Pool's daily operations as well as its 12 employees. The Insurance Pool operated on an annual budget of approximately \$11.5 million.
